Grease Trap: including grease, oil, solids, or water that results from the preparation or manufacturing of food

Natural Organic Fibrous Material: Bagasse, peat, seed hulls and husks, straw, and the like.

Biosolids: General solid waste (non-putrescible) is the organic product that results from sewage treatment processes

Definitions

Inclusions

Food Waste includes: liquid and solid food waste from supermarkets, kitchen scraps from commercial restaurants, compostable waste from food manufacturers and council's kerbside food organics collections (FOGO).

Garden Waste includes: any garden plant material including garden waste either from a commercial landscaper or gardener, council landscape and verge clearing or from kerbside collection.

Exclusions

Liquid and Solid Food Waste excludes: corrosive products, animal waste (e.g. abattoir waste). All packaging must be removed or certified compostable.

Garden Waste excludes: asbestos, engineered wood products or preserved treated coated wood residues.

Biosolids excludes: trade waste discharges, septic tank sludges (seepage) and night soil screenings, grit and scum, sewer silt and stormwater waste, industrial waste, and drinking water treatment sludges.
